### **BEFORE TREATMENT**

If you are concerned if the BB Glow treatment is suitable for you, we do recommend to discuss this with either your dermatologist or medical skincare professional who is experienced in these types of treatments in order to achieve the best possible outcomes and to minimise the risks. For example, certain types of medication, such as those for acne treatment or for blood-thinning, may need to be stopped taking beforehand to reduce the risk of side effects. If you are concerned about an allergic reaction, a test treatment can be done to see how your skin reacts with BB creams application before the procedure. ### AFTER TREATMENT

After you have had your BB Glow treatment it is recommended to follow a few steps in order to assure the most effective outcome and lasting of the treatment.

No excessive facial cleansing for a minimum of 24 hours

No skin touching for a minimum of 12 hours

5 days with no make-up or skin peel

7 days with no swimming

14 days with no direct heat including sunbathing, sauna, or sun bed

We do also recommend an application of moisturising and nourishing cream with a high factor SPF .Initial

## BB GLOW FREQUENTLY ASKED QUESTIONS

### What is BB Glow?

BB Glow is a combination of powerful tinted serum applied using Microneedling method - an intensive skin treatment that uses state-of-the-art technology to penetrate first layers of the skin with microneedles which are rapidly released from a Microneedling pen (don't worry - it's painless!). One of the main benefits of basic microneedling is stimulation of natural collagen production and skin rejuvenation, where the BB Glow serum adds incredible nutrients and most importantly the color tint you desire. BB Glow is designed to improve the look and feel of your skin fast. Visible improvements will be apparent immediately after the first appointment. The serum will also continue to work for two weeks after your treatment, and anti-aging benefits will continue to roll in in the coming weeks as your skin naturally rejuvenates itself after microneedling manipulation.

Some of the improvements you may notice include:

More even skin tone
Brighter, more radiant skin
Fewer freckles
Less skin discoloration
Fewer fine lines and wrinkles

### What is the application procedure?

Each application takes about 1,5 to 2 hours depending on a skin type of a client. A consultation is necessary before the procedure due to the selection of the closes shade of BB glow. Usually, two to three BB glow are mixed together to customise a color for each client.

## How long does it last?

The effects of the treatment are individual and may vary from person to person depending on the skin condition and a post treatment after care. Immediate results may be seen straight after the first procedure. However, the BB serum has a cumulative effect which means that it builds up under the skin with every single treatment. Therefore, a number of 2 to 5 treatments at 10 to 14 days intervals are recommended to achieve the best long-lasting results possible.

Expected lasting effect

1 to 2 applications = lasting up to 2 to 3 months 3 to 5 applications = lasting up to 9 months

## What are the Benefits of BB Glow Treatment?

There are two main reasons that make BB Glow so attractive. Firstly, the procedure makes your skin appear as if you are wearing foundation without having any. It is a vanity reason, but nevertheless it can have a huge confidence boost for someone struggling with acne scars or pigmentation to be able to cover them up semi-permanently. Secondly due to microneedling component of BB Glow it is a powerful anti-aging procedure, boosting collagen production.

Not to get ahead of ourselves, why is Collagen so crucial? Collagen is a natural protein found throughout the body, it provides the skin with structure, elasticity, and vibrancy. At a young age we have plenty of it and it is naturally replenished by the body; unfortunately, as we age the body produces less collagen. This leads to wrinkle formation, loss of skin elasticity and firmness. Therefore, stimulating collagen production can improve the look and texture of your skin, lessen the appearance of fine lines and wrinkles.

Another added benefit of BB Glow treatment resides in the serums, which are made from purely natural and potent nutrients. Microneedling technique used to apply BB Glow serums help them penetrate deeper into the skin delivering the nourishing components where they will have the most benefit.

### Will BB Glow clog my pores?

No, BB Glow will not clog pores. This idea originated from a traditional makeup where particles are too large and the ingredients are not designed to benefit the skin per se. BB Glow serums are formulated to be beneficial for the skin, even the tint that provides the color is completely natural and non-comedogenic, meaning free of silicones; therefore it will not clog the pores.

## **BB GLOW AFTERCARE**
